Situation

MT South is a medical transcription company, based in Knoxville. The company listens to dictated recordings made by physicians and other health professionals and transcribes them into medical reports, correspondence and other administrative material.

With MT South being a small business, it was necessary to find the perfect solution to their leasing requirements and professional support needs, which included a one or two person office arrangement, as well as assistance with IT administration. All of their needs - office space coordination and IT support - had to be implemented and delivered within a short timeframe.

Solution

MyNextSuite provides MT South a turn-key office environment though the single office solutions arrangement. Ultimately, the owner of MT South leased two conjoining StaffTechs recommended an open source solution using existing and mature technology. The solution uses a Linux file server configured for secure file transfer (SFTP) via secure shell (SSH) connections. Linux was selected to minimize costs by eliminating license fees from the potential expenses of the system, as well as providing a secure file transfer platform.
